AGREEMENT OF STUDENT AND FLYING MEMBER

To the Secretary
Tasmanian Aero Club
Launceston Airport

In consideration of you accepting me as a student for instruction in Flying, or as a Flying Member of the Tasmanian Aero Club. I forward herewith the sum of \$ _____ for one year's subscription for the year of _____ and I hereby agree as follows:

1. That I will pay to the club the fees from time to time charged by the club for instruction in flying or for use of the Club's aircraft or equipment.
2. That I will at all times be subject to and obey the rules, by-laws and regulations of the Club and instructions, directions and orders of the Club Secretary, Instructors and Officials.
3. That the Club may at any time without assigning any reason refuse to instruct me or to permit me to fly in the Club's aircraft, and that on such refusal the Club shall not be bound to refund to me any entrance fees, subscriptions or other fees paid by me.
4. That I will attend any lectures, demonstrations or practical instructions from time to time prescribed by the Club that will carry out such practical work on the Club's aircraft and engines as may from time to time be required.
5. That the Club shall be in no way responsible for any personal or material accident or damage suffered by me during the period when I am undergoing instruction or am hiring an aeroplane for solo or passenger flights or am on the Club's aerodrome or premises whether caused by default, neglect or lack of skill of the Club's officials or servants or servant's employees or through any defect in the Club's equipment otherwise howsoever.
6. That the Club shall be in no way responsible for any damage to third parties or the property of third parties caused by my act.
7. That I shall pay the club in full any loss suffered by the Club or any damage done to the Club's aircraft, stores or equipment caused by my failure to obey the rules, regulations or by-laws of the Club or the directions or instructions or orders of the Club's instructors or officials.
8. That subject to the proceeding paragraph I shall, if requested by the Committee reimburse the Club to an amount not exceeding \$20.00 for any damage suffered by the Club's aircraft or property whilst I am a pilot of such aircraft suffering or causing damage.
